PARISH VERGES UPDATE June 2022

Since my report in the Parish Magazine about the Parish Council taking over the responsibility of cutting our verges from HCC Highways, and after much negotiation we will at last be using our own Contractors. The main cut will be at the end of July. Hopefully, most flowers should have seeded by then. The RVEIs (Road Verges of Environment Interest) will be treated separately as to their special requirements.

We do still have to adhere to many of the HCC Highways specifications. That said, this is a pilot scheme and subject to annual review.

We willing be working, as much as we can with advice from PlantLife, and gathering information on our special plants on our RVEIs. We will also be working closely with the South Downs National Park with their renaturing project.

As we will be cutting later we would like your help with the following:-

• reporting any visibility problems on junctions and bends. Please could you contact Helen, our Parish clerk clerk.froxfield@parish.hants.gov.uk or 07555 062065 or myself - teresa.mbrown2011@gmail.com with exact locations and details, so that we can make arrangements for a safety cut to be carried out as soon as possible.

And for your own interests please note that:-

• under the provisions of the Highways Act 1980, it is an offence to block, obstruct or damage road verges. This includes rocks, posts, A-boards etc. If someone is injured or damages their vehicle on rocks or posts etc, legal action could be taken against you as the homeowner if you have placed these items on the verges.

It will take a few years for our area to regain the old habitat which has been gradually disappearing, caused by the damage of the early cutting over the years. It would prove useful if you could advise me of any new or returning wild flowers and creatures that you see on our verges, and become part of the 'VergeWatch' team. It would be a great help for the progress of this project to have a record of our flora and fauna including any photos.
