  - a) Planning Application SDNP/22/02019/LIS: The Old Forge Alexanders Lane: Listed building consent: Provision of conservation roof light to south east roof slope and internal works to create opening to internal wall between the kitchen and the family room. ## Any other business

- a) Following the resignation of Cllr Robert Smith, a vacancy notice had been posted. If there has not been a call for an election the parish council can co-opt a Councillor. It was agreed that Privett was under represented. The Clerk will advertise the vacancy in the parish magazine and Cllr Brown will post an advert on Privett's social media platform.
- b) The defibrillator guardians had reported that 2 of the cabinets were showing signs of rust and the battery expiry dates were imminent. The Clerk had ordered 3 sets of new pads, child pads and replacement batteries, which all fall under the 8-year guarantee. The expiry dates will now be the same for all 3 defibrillators. The clerk will take up the rust problems with the manufacturers of the defibrillator cabinets.
